Admission Fees (per person)

Adult	500 yen (100 yen)
Groups of 30 or more	450 yen (90 yen)
Groups of 100 or more	400 yen (80yen)
Annual pass	2,000 yen (600 yen)
Sky Tower joint pass	640 yen (160 yen)

Admission is free of charge for visitors of junior high school age or under.
Admission is free for the holder and two caregivers
(in cases where caregiving is required) upon presentation of any of the
following documents (no copies accepted) at the admission gate.

1. Physical disability certificate
2. War injury and sickness certificate
3. Atomic bomb survivor certificate
4. Treatment (rehabilitation) handbook
5. Health and welfare service passport for persons with mental illness

Note: Admission fees in parentheses are for persons 65 years of age or older
who reside in the city of Nagoya.

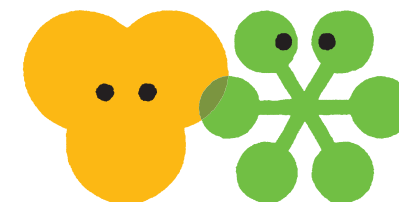

Access Guide

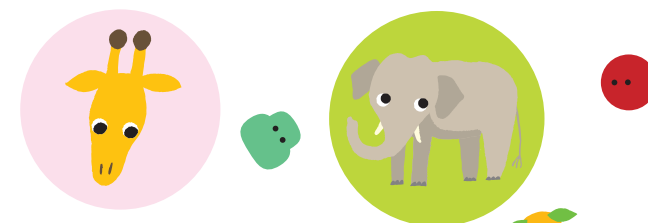
- 3-minute walk from Higashiyama Koen (Higashiyama Park) Station or 7-minute walk from Hoshigaoka Station, both on the Subway Higashiyama Line (Hoshigaoka Station offers convenient access to the Botanical Gardens.)
- Approx. 15 minutes west by car from Nagoya Interchange on the Tomei Expressway
- Approx. 10 minutes west by car from Kamiyashiro Interchange on the Higashi-Meihan Expressway
- Approx. 10 minutes east by car from Yotsuya Exit on the Nagoya Expressway Because traffic is prone to congestion and limited parking is available, please make use of public transportation.
